A R R O W

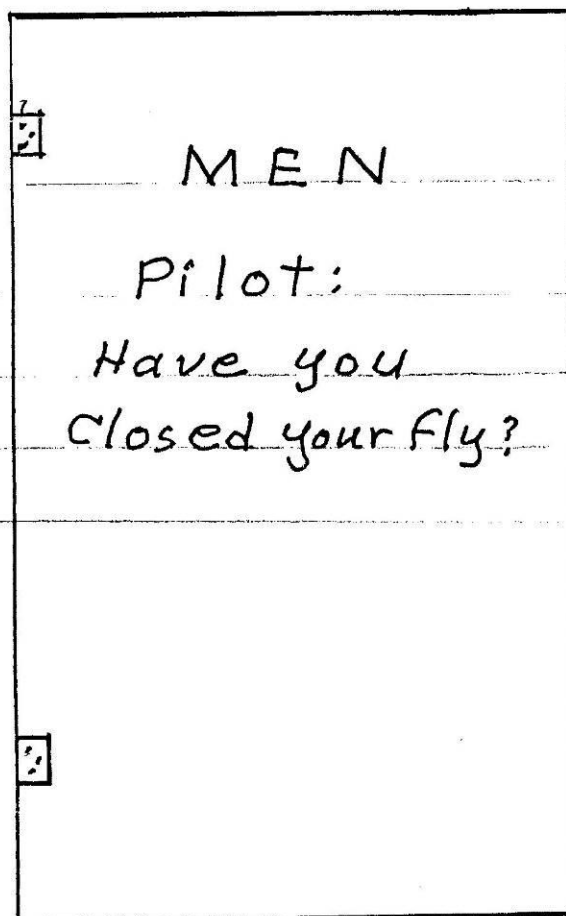
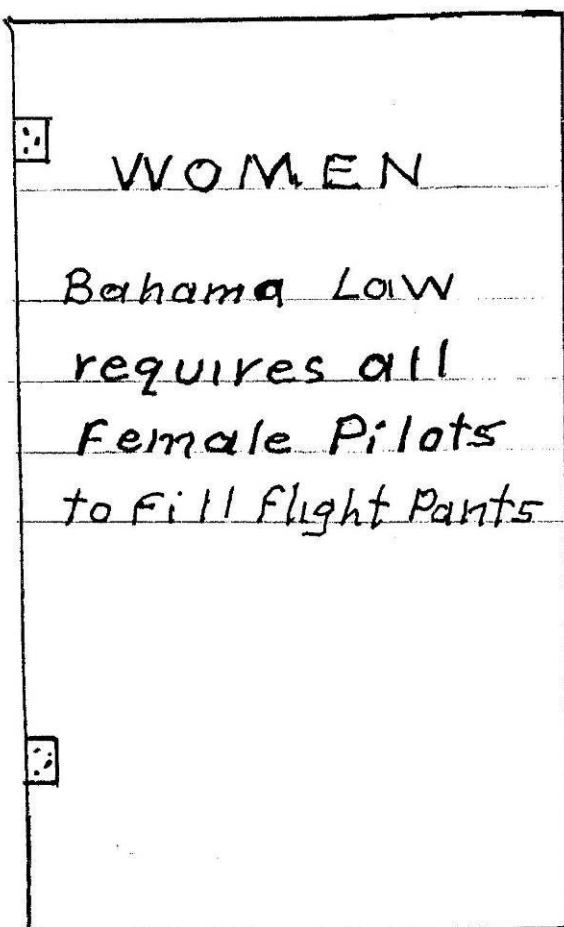
- A - Airworthiness Certificate

The date for the 1990 Xmas party was announced to be December 2nd at the Legion club.

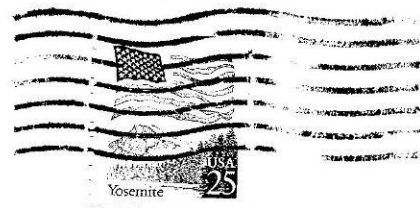
Dr. Dwight Snyder gave a talk on aviation medicine and FAA physical requirements.
