EAGLES NEST UPDATE

Finally, some good news. The planning commission gave their approval on our Eagles Nest project wednesday afternoon. They did impose some additional restrictions, the most troublesome probably being that the airfield can only be used by property owners. This means we cannot invite guests to fly in for a visit. Their concern, of course, is that we might create too much traffic. Personally I think this infringes on our rights, but I guess we have to take what we can get.

The successful outcome of this vote was largely due to Don Shoemaker's intensive lobbying of the commissioners, making sure they were educated about flying regulations and the difference between airports and airfields. It was obvious during the discussions before the vote wednesday that he had done a great job. They didn't have it all right, but it was close enough.

The next step is the hearing before the County Commissioners, probably in about 4 to 5 weeks.

6TH ANNUAL **AVIATION ART** AWARDS CEREMONY


APRIL 24, 1993
