Attention Low Altitude Fliers

All pilot operations at low altitudes in the Mead, Ashland, and Hastings areas should be aware of the National Guard Firing Ranges in those areas. Low altitude operations around these areas could obviously be hazardous. One incident has occurred when an agricultural aircraft flew through one of these areas WHILE FIRING WAS IN PROGRESS!

These ranges will be in use every weekend from now until December 1, 1995. Occasionally there is firing on weekdays. A check with the FAA AFSS (NOTAMS) is suggested to determine if the ranges are firing or not. Also, be aware that the Mead area is an approved drop zone for military parachute operations.

2nd Annual Harvard Airbase Aviation/Military Fair

On September 8,9 and 10, 1995, the 2nd annual event will be held at the Harvard Airbase, located about 16 miles South of Aurora on Hwy 14.

Harvard Army Field was constructed in 1942 from 1,740 acres of Clay County farm land. Work was started on the field September 17, 1942 and completed November 19, 1942. The Army took over on December 16, 1942. The site was located three miles northeast of the city of Harvard, Nebraska. On July 1, 1943 the base had 278 officers and 3,030 enlisted men. From 1942-1945 seven bombardment groups were stationed at Harvard flying the B-17, B-24 and B-29 bombers. The base was decommissioned in 1945.

This year's Harvard Aviation Show will emphasize the 50th anniversary of the end of World War II as well as aviation in general. They are expecting 20,000 spectators for the 2-day event. They are encouraging all types of aircraft to fly-in for static display. Many different types of military and aviation related displays will be presented on the field. Special ceremonies will be held to commemorate the end of World War II. They will be welcoming veterans from all wars our country has fought in.

Airbase attractions will include Ultralights, Warbirds, Kit Plane Manufacturers, Fly-bys, Ag-Planes, Military History, RC Aircraft, High Power Model Rocket Club, Home Builts, Military Fly-bys, Antique Aircraft, Current Military Hardware, Demonstrations, Ceremonies, Awards, Display Booths, Food Vendors, Sky Diving Lessons, Scuba Diving Lessons, and much more.


Homebuilders Delight
